1 Director's Annual Report 2003

1.1 Introduction

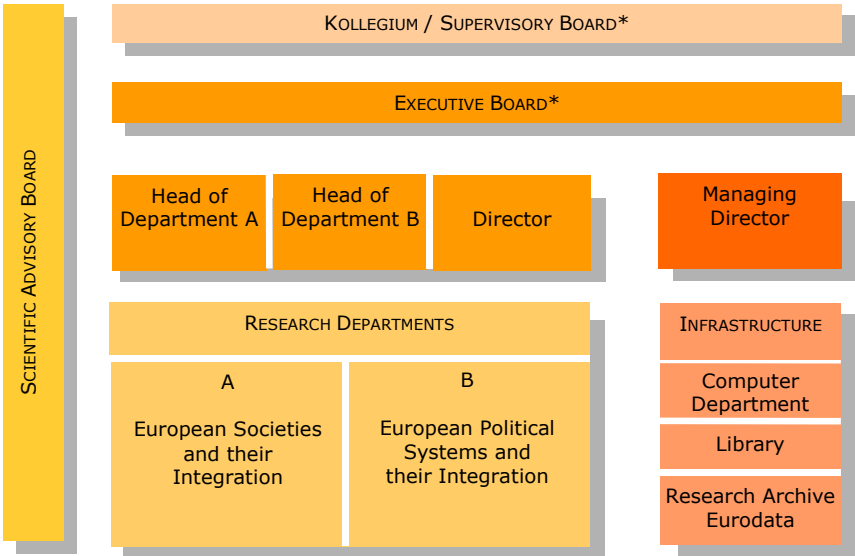
The central goal of the Mannheim Centre for European Social Research is to do empirical social science research on the development of the European societies and their political organization. It combines the comparative analysis of societies and political systems in different European nations with research on the process of European integration and its repercussions on the development of the national societies and nation-states.

In its first part, this report briefly describes the essential developments at MZES in 2003. It summarizes important changes in the composition of its personnel and researchers, describes the development of its resources, project grants, and infrastructure, portrays its

various types of cooperation and involvement in national and international exchange, and sums up its publication output. The second part contains an overview of projects carried out at the Centre in 2003, followed by a series of lists and tables which summarize the main activities of the Centre during the year 2003. Detailed descriptions of the work done and results obtained in the various projects carried out at the Centre can be found on the MZES homepage. There, each project is briefly described together with the names of contact persons who are happy to provide more information.

In 2003 MZES decided to undergo a formal evaluation by an outside peer evaluation committee. For this purpose MZES prepared an extensive research report for the years

1999-2003. MZES also prepared various documents that describe other MZES activities and achievements in this period. A revised version of these materials will be published soon. Therefore, this annual report for the year 2003 is shorter than the MZES annual reports usually are. We are glad to provide the more detailed documents to interested readers.

MZES works under the organisational structure above.

Research at MZES is organised in two Research Departments. Each department concentrates research along a number of more

specific Research Areas. Each Research Area generally includes a number of *core projects* (which cover the main research question of the Research Area) and *supplementary projects* (which complement the main theme of the Research Area with topics related to it but not constituting its core domain). The Research Areas are coordinated by the Research Area coordinators, usually Professors of the Faculty of Social Sciences, senior researchers at MZES or advanced Assistant Professors of the Faculty. The following chart lists the present Research Areas of each of the two Research Departments.

In 2003 MZES engaged in 63 projects with a total of 72 researchers. About 50 student assistants have also contributed to the work of the Centre. A brief description of the research questions pursued and of the projects carried out in each Research Area is included in the second part of this report.

1.2 Personnel Development

The Faculty of Social Sciences has entered a major transition period. Within a few years almost all professors will retire and new colleagues will be recruited. This obviously also affects MZES as the Faculty professors serve in many leading roles at MZES. In 2003 Johannes Berger was elected to succeed Peter Graf Kielmansegg as the Chair of the Kollegium (Supervisory Board) of MZES, due to the retirement of the latter. Graf Kielmansegg had served as Chair of the Kollegium since 1999 and was also a member of the committee that developed the new MZES constitution enacted in 1998. MZES owes Graf Kielmansegg a great deal for his professional steering of the meetings he chaired and for his always considered and helpful advice. In the name of MZES the Executive Board extends deeply felt thanks to Peter Graf Kielmansegg for his supportive engagement for MZES.

In autumn 2003 Wolfgang C. Mueller succeeded as professor to the Chair for Comparative Government and Political Theory, previously held by Graf Kielmansegg. Immediately after his arrival, Wolfgang Müller started to actively participate in research at MZES. He has suggested to concentrate his research at MZES on "Legislative Politics and Law-Making in Europe" and has started an initial research project on "Intra-Party Politics and Coalition Governments". MZES welcomes Wolfgang Müller as a new colleague

and is very pleased that he so speedily has started research highly relevant for the Centre.

In 2003 the Faculty of Social Sciences also started the search for two replacements to sociology chairs (the Chair for Sociology III / Macrosciology and the Chair for Methods of Empirical Social Research and Applied Sociology). MZES expects that later in 2004 new colleagues will take charge of these chairs and then also bring new inputs to sociological research at MZES.

In 2003 MZES also experienced several departures and new arrivals of researchers and other staff members. Even though they are not mentioned here in person, the Executive Board welcomes each newcomer and thanks for their contribution to MZES all those who for various reasons have left the Centre during the year.

1.3 Other Resources and Project Grants

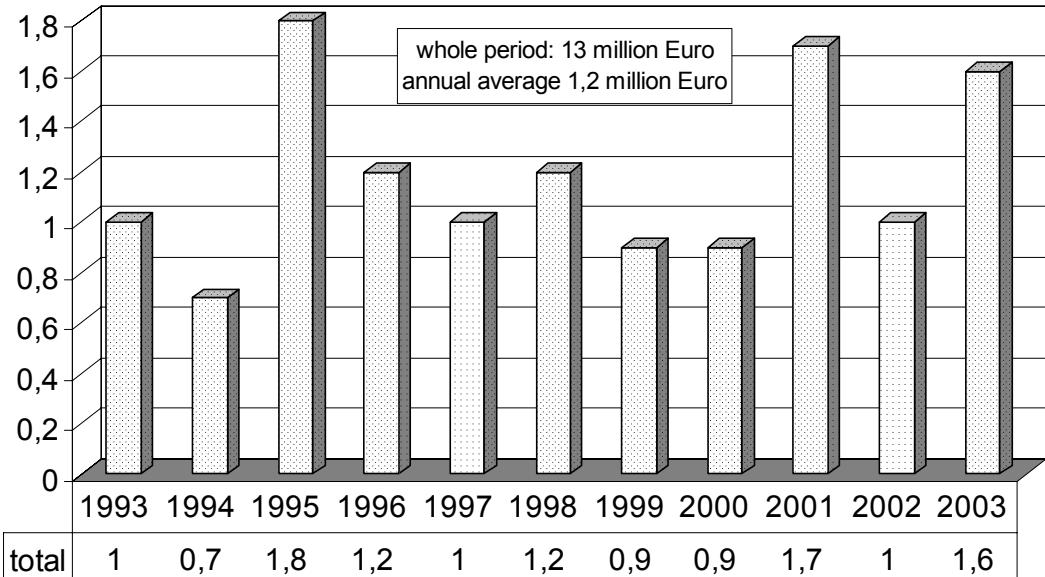
In 2003 the Centre could draw on a basic state budget similar to the budget of previous years. These resources are part of the state of Baden-Württemberg's budget for the University of Mannheim. They provide for 24 full-time positions for research, infrastructure services (data and information archive, library, computing) and administrative and secretarial staff, and additionally include free use of office space and about 500.000 Euro per year for additional personnel and other expenses. The Centre uses these resources mainly for an excellent infrastructure for research, long-term general services, administration, and, in particular, as seed resources for the preparation of research proposals for research grants and for the support of projects that have been evaluated positively

through peer review procedures and have obtained outside grant income.

In the past the Mannheim Centre has been very successful in gaining research grants. For years the MZES has been among the most successful grant-winning institutions of Mannheim University and through this has become the largest research institute of Mannheim University. In 2003 the high level of external funding achieved in previous

years was sustained. In the last eleven years a total amount of 13 million Euro has been acquired, resulting in an annual average of 1.2 million Euro. In 2003 the Centre obtained 1.6 million, i.e. far above the long-term average. The level of resources acquired in 2003 speaks for the vitality of the Centre and its strong position in the competition for research grants.

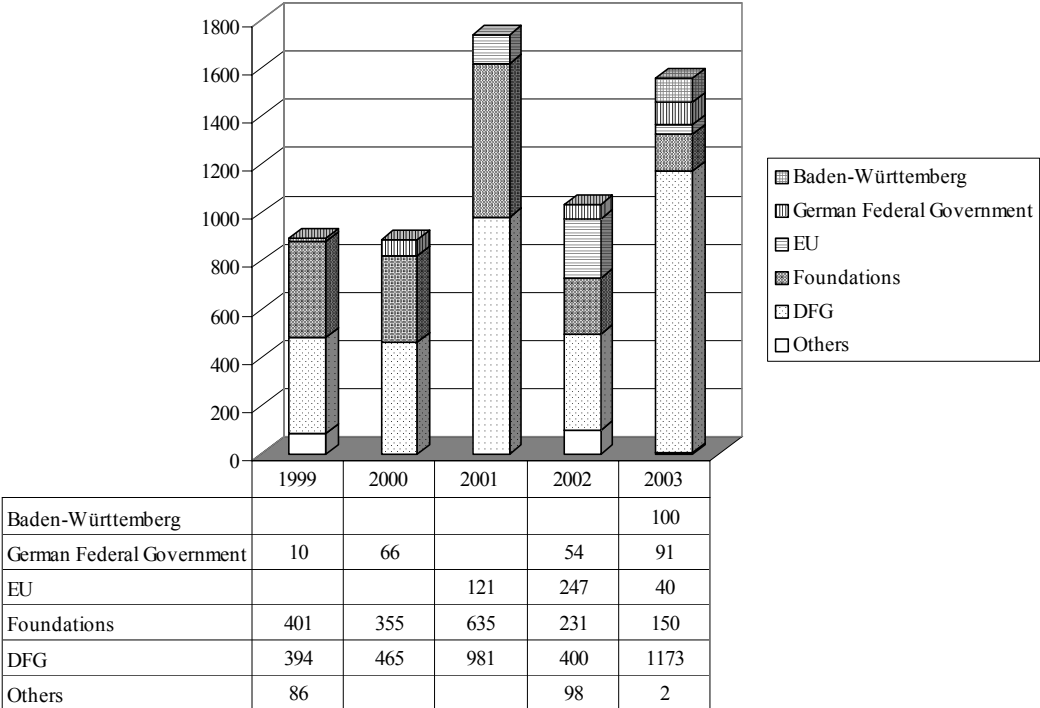
Figure 1: Acquired New External Funding 1993 – 2003

Most of the research grants continue to be obtained from institutions that submit proposals to strong peer evaluation. As in previous years the main source of funding is the German Research Foundation. Smaller parts of the research budget are provided by the Volkswagen and Thyssen Foundations and by the State of Baden-Württemberg and by Ministries of the German Federal Govern-

ment. While most of the resources are provided by German sources, the proportion of European funds is rising. The new EU funds have been obtained for a new EU Research and Training Network "Dynamics and Obstacles of European Governance" and for the Research Network "Economic Change, Unequal Life Chances and Quality of Life".

1.4 MZES infrastructure

The MZES infrastucture (including the library, data archives and computing services) is among the very valuable ressources that support efficient work at the Centre. For 2003 the following specific achievements merit mention:

- 1. In the library of the Centre, efforts have been strengthened in 2002 (with allocation of temporary additional personnel) to integrate the catalogue of the MZES library into general library catalogues that document holdings in a unitary system and make the titles available online (books in the Union Catalogue of the South West German

Library Consortium; periodicals in the German National Catalogue of Periodicals). This project has made very good progress in 2003. As we see it now, this project can be concluded earlier than expected and the resources will be free for other purposes. Connected to the improved information about our library holdings there is a growing demand for them from outside MZES.

- 2. The Eurodata Archive is closely observing the rapidly changing publica-tion policies of the statistical agencies – increasingly statistical data are not pub-lished in print any more but provided on the Internet. The archive is developing

strategies in order to react best to these changes.

3. The publication of data handbooks in the "Societies of Europe" series is making progress as well. During this year two new volumes have come close to being ready to go to print. They will appear in 2004. The first of the published volumes – the volume entitled "Elections in Western Europe since 1815" by Daniele Caramani – is out of print and will be reprinted.

4. Finally, connected with the Eastern enlargement we have decided to revise our library acquisition policy. From now on we will collect publications on the new member countries according to the same criteria as publications on the present EU member states.

1.5 Cooperation and exchange

Research of the scope and content carried out at the MZES is only possible with intensive cooperation within the MZES and with research groups and colleagues outside the MZES, both nationally and internationally. On all these levels, MZES has continued to be successfully engaged and has added several new elements.

Within the Centre the regular seminars of each of the departments have provided ample opportunity to discuss ongoing work of projects and to exchange with invited colleagues from outside the Centre (see the list of seminars in the appendix). Also the joint seminar of the MZES and the Faculty of Social Sciences with distinguished outside speakers contributes to making the MZES a place of lively exchange and intellectual discussion. The ad hoc interdisciplinary working group with members from various parts of the Centre who are working on

France continues to meet and has written common papers. The number of projects in which researchers from different Research Areas work together has increased. Instead of training workshops that previously were organised by the Executive Board we now have for instance working groups on methods that are initiated and organised by the researchers themselves.

Within the Mannheim scientific environment MZES highly profits from cooperation with colleagues of other faculties of Mannheim University and other institutions. For instance, MZES hosts the German Research Foundation-financed interdisciplinary research group "Institutionalization of International Negotiation Systems", in which MZES researchers cooperate with researchers from chairs in the Economics and Law Faculties of Mannheim University as well as with researchers from the Centre for European Economic Research (ZEW), Mannheim. MZES researchers are also participating with two projects in the German Research Foundation Special Research Centre (SFB 504) "Rationalitätskriterien, Entscheidungsverhalten und ökonomische Modellierung", based at Mannheim University. With ZUMA MZES cooperates inter alia in the context of the CHANGEQUAL network (see below).

Also on the national and international levels MZES has maintained its presence and good position. Many MZES researchers have participated in numerous national and international conferences. They have presented papers and convened various workshops and organised conferences at MZES and abroad. Several MZES colleagues have leading functions or cooperate in several national or international cooperation networks:

- Jan van Deth directs the German national co-ordination team of the *Euro-*

pean Social Survey which collects survey data in 23 European nations designed to chart and explain the interaction between Europe's changing institutions and the attitudes, beliefs, and behaviour patterns of its diverse populations. With this involvement the MZES is participating in a leading role in one of the most important academic investments for comparative social research in Europe. Van Deth also played a central role in the international team preparing the ESS questionnaire module on Social Capital for the 2003 survey. Brüderl participates in the international group which has won the competition to design the module on "Family, Work and Well-Being" for the 2005 survey. MZES researchers will participate in various international groups to analyse the data.

- Beate Kohler-Koch continues leadership in the Special Research Area of the German Research Foundation (DFG) on *Governance in the European Union*.
- Beate Kohler-Koch and her team are also involved in the EU Framework Programme Research and Training Network on "Dynamics and Obstacles of European Governance", which aims at cooperating with partners in several European countries in ongoing research and at improving training of young researchers in the study of the performance and deficiencies of multilevel governance in the EU. Among others the network includes cooperation with research institutes or university departments in Amsterdam, Cologne, Florence, Harvard, Oxford, Stockholm, Tilburg, Vienna.
- On a much wider basis research cooperation on multilevel governance in the EU will take place in the CONNEX Net-

work (Connecting Excellence on European Governance), which has recently been approved as a Network of Excellence in the 6th EU Framework Programme to study "Efficient and Democratic Governance in a Multilevel Europe". CONNEX will start its activities in summer 2004. Under the leadership of Beate Kohler-Koch MZES has gained the cooperation of about 60 established research centres and about 170 distinguished scientists throughout Europe for this network and will coordinate its various activities.

- With leading participation of MZES researchers (Brüderl, Esser) a new DFG Special Research Area Programme has been established to conduct a large-scale and long-term panel study on the *"Development of Relationships and Families"*. Cooperation partners will particularly include the research groups in Germany which participate in this panel study, but also colleagues from the similar Netherlands Kinship Panel Study (Dykstra, Kalmijn, Liefbroer, Mulder) and several colleagues working in other countries on related issues (e.g. Amato from Penn State University; Billary from Bocconi University in Milano; Diekmann from ETH, Zürich; Hoem from MPI für demographische Forschung in Rostock and Kohler from the University of Pennsylvania).
- *Economic Change, Unequal Life Chances and Quality of Life (CHANGE-QUAL)*: The aim of this network – in Mannheim led by Walter Müller – is to intensify long-term research cooperation among several outstanding European research institutes working in highly overlapping areas. Cooperation partners are ESRI, Dublin; LASMAS (CNRS), Paris; Nuf-

field College, Oxford; Sociology at Bicoca Milano; Sociology at Tartu University and SOFI Stockholm. The consortium of institutes has established five topical research groups in which experts from each participating institute contribute to common projects. The topics closely correspond to research priorities in several Research Areas of MZES Department A and Research Area 1 in Department B. In 2003 MZES organised the first international workshop of this network, which took place at MZES in April 2003.

1.6 Publications

The lasting results of a research institute are its publications. As is visible from the list of publications in the appendix, MZES enjoyed a high publication record in 2003. Several of its publications have appeared in first-rate international scientific journals or as books and edited volumes published by renowned academic publishing houses. A summary view can be gained from Table 1, which counts publications in various categories. Among

journal articles a distinction is made between articles that are reviewed in the Social Science Citation Index (SSCI), articles in other scientific journals and articles in non-scientific journals that we mainly publish to reach the wider public. In terms of the total number of written publications MZES reached exactly the same figure in 2003 as in the year 2002, in which MZES had the largest absolute number of publications in a year so far. Between the two years there are only minor changes across the categories of publications. Perhaps the most significant change is that the number of in-house publications in working papers has declined, while the number of external publications (articles in journals or edited volumes, the publication of which depends on the evaluation of external editors) has increased. However, one should not make too much out of these differences, as they are based on small numbers and may result from short-term contingencies rather than a systematic change.

In both years together, MZES authors have published each month on average one to two books, one to two articles in a journal reviewed in the Social Science Citation Index and several articles published in other scientific journals or in edited volumes. While in the German context the SSCI publication record is encouraging¹, it is certainly not at or near the top in an international perspective. In order to increase the international visibility and reception of our results, it is essential to increase the proportion of publications in SSCI journals. This strategy is also advisable because these journals tend to have the highest external quality control.

All in all, MZES has again experienced a good and successful year. The Executive Board wishes to thank the many institutions and persons who have made this possible: Mannheim University for the continued and generous support; the research funding agencies for their grants and their trust in our scientific promise, our many colleagues from out-

side for their stimulating and rewarding cooperation, but especially all our staff and MZES members for their enthusiasm and the efforts they devote to the common enterprise.

2 Brief Research Report

Department A: European Societies and their Integration (Head: Hartmut Esser)

Research in research Department A generally focuses on analysis of social structures and welfare organizations in modern societies. The projects study the cultural, social, economic and welfare-state-based foundations of living conditions in Europe, their change and their variation in different European societies. Concrete research areas are social inequality, especially in the fields of education and the labour market, the development of welfare state organizations, migration and inter-ethnic relations, the moral foundations of societal integration and the development of family and kinship relations.

Conditions of life are assumed to be largely shaped by the results of economic markets, by the regulatory and redistributive actions and interventions of the state, by the support and exchange relationships within families, households or other units of partnership, and finally by intermediary social associations and organisations such as the trade unions, churches or other welfare producing agencies. To a smaller or larger extent all these core elements in the generation of conditions of life and welfare are under study in various projects. Research, however, concentrate on how changing social structures and the transformation of welfare state institutions and policies affect conditions of life. Particular emphasis is also given to the impact these changes have for the degree of social inequality and the social and cultural differentiation in European societies. The latter notably is true for the studies of the consequences of mass immigration for the social integration of migrants, for interethnic conflicts and for the relationships between host countries and countries of origin.

Research Area A1: Development of Social Structures in European Societies (Coordinator: Walter Müller)

Education, work and incomes, the living arrangements in families, partnerships and social networks, and the provisions of the welfare state are the most lasting determinants of life chances of individuals in modern societies. The projects study how and why these elements are interrelated, how they have changed in the economic and social developments of the last decades and how and why the European societies still differ in these respects.

(Coordinator: Peter Flora)

Starting from a Rokkanian perspective of European state formation and nation-building, the single projects study various aspects of the historical development and current structure of the social services and social security of European welfare states.

Research Area A3: Migration, Integration, and Ethnic Conflicts

(Coordinator: Frank Kalter)

The projects in this research area deal with the causes of transnational migration, on the one hand, as well as with its consequences, on the other hand. With respect to the latter special emphasis is put on the 'structural' dimension, e.g. on the integration of immigrants into the educational system and the labor market. Generally, an attempt is made to make use of new theoretical developments in order to answer the respective questions. Further, all projects try to test the underlying mechanisms empirically using or collecting appropriate data sets and applying quantitative methods.

Research Area A4: Cultural Foundations of the Market Economy and the Welfare State (Coordinator: Johannes Berger)

The general objective of the projects in this research area consists in the analysis of the cultural and normative foundations of the market economy and the welfare state. A specific normative structure is characteristic for both market economies and the institutions of social policy. Not only the latter but the further, too, are founded on specific ideas of social solidarity and justice. Starting from this general framework the individual research projects aim (1) at clarifying to what extent the ideas concerning social solidarity and justice coincide with value orientations and collective representations of actors. (2) The projects address the question how the different normative orientations of the welfare state and the market economy interact. Especially in the public debate the view is widely held that the spread of value orientations typical for a market economy will eventually undermine the social bond necessary for the social cohesion of society.

Research Area A5: Family and Social Relations

(Coordinator: Hartmut Esser)

The projects in this research area deal in general with the emergence and change of personal social relations that can be observed throughout European societies. Particularly, it will be analysed how intimate relationships, marriages and families emerge, stabilise or also break up again. Besides the traditional model of marriage and family alternative forms of organising intimate relationships, marriages and families will be taken into consideration.

Department B: European Political Systems and their Integration

(Head: Franz Urban Pappi)

Research Department B combines comparative research on European national political systems with research on European integration. The first three research areas focus on comparative politics (political participation and voting behavior, political parties, electoral systems), research area 4 focuses on the political system of the European Union, area 5 on the international embeddedness of European governance, research area 6 on the institutionalization of international negotiation systems and research area 7 on the development of a further European regional system in Eastern Europe.

Research Area B1: Engagement, Participation, and Voters' Behaviour

(Coordinator: Jan van Deth)

Projects in this Research Area concentrate on democratic decision-making and the process of interest articulation with an emphasis on individual behaviour and orientations. They focus on the development of various modes of engagement and participation. Major themes are the relationships between social and political engagement and the development of 'civil society', the opportunities of new information and telecommunication technology for political participation, and the political socialisation of young children.

Research Area B2: Political Parties and Political Linkage

(Coordinator: Hermann Schmitt)

The importance of civic engagement and participation in voluntary organisations notwithstanding, in representative democracies it is political parties who are the key intermediaries between citizens and the state. Among other things, they are organising general elections; formulating electoral platforms; mobilising the electorate; structuring the vote; and forming governments. Through all of this political preferences of voters are formed and transformed (or: translated) into electoral mandates of party governments, and ultimately into public policy.

While political parties have been in charge of this linkage function in most of the 20th century democracies, they are now confronted with major challenges. These challenges affect both angles of political linkage, the citizenry and government, as well as the very process of political linkage. The central research question of this research area is how political parties are performing their linkage task between citizenry and government under conditions of social-structural change and in different political-structural environments. All projects in this area, while theoretically motivated, are strictly empirically oriented.

Research Area B3: The Election of Parliaments as a Coordination Problem of Parties and Voters (Coordinator: Franz Urban Pappi)

In multiparty political systems, voters have to choose parties in parliamentary elections which are not automatically options for specific future governments. In addition to the election results, government formation depends also on the parties' coalition bargaining after the election. The central research question of this research area is how voters try to influence government formation by strategic voting, i.e. choosing not their most preferred party, but a party which may lead to their most preferred government.

Research Area B4: Governance in Europe (Coordinator: Beate Kohler-Koch)

Governance in the EU and in the European political systems is characterised by multiple interlocking institutions. Negotiations take place at national, European and international level – and often the same topic is negotiated in different arenas and among different actors. Governing on more than one level has brought about institutional changes and has transformed the strategies of negotiation, representation of interests and institutional design pursued by the participating actors. At the same time, these transformations are an important driver for this new type of governance. Research area B2 focuses on the empirical analysis of such processes. An overarching objective is to find forms of democratic legitimation for decisions that are binding and relevant for the whole of European societies, but cannot be adequately dealt with within the national institutions of parliamentary democracy.

Research Area B5: International Embeddedness of European Governance

(Coordinator: Michèle Knodt)

European governance is characterized by a strong interdependence of international changes on the one hand and changes occurring at the national, transnational or European level on the other. In this context, research in area 5 is focusing on one dimension of these interdependent processes, i.e. on the embeddedness of European governance in the international context which has a strong impact on the character of national, transnational as well as of European governance. The central research questions of this research area are: (1) How does the international context bring about institutional change within the EU? and (2) How are international governmental and non-governmental activities co-ordinated in Europe?

Research Area B6: Institutionalization of International Negotiation Systems (Coordinator: Paul Thurner)

Negotiation is of growing importance in managing international problems, in interactions between both governmental and non-governmental actors. As in the domestic sphere, international negotiations take place in relatively loosely-organized systems as well as in hierarchical organizations, and take a more or less institutionalized form of decision-making. The localization in various functional contexts of action and in institutional settings requires an interdisciplinary scientific research approach. The main questions of the research group are:

- Which different forms of institutionalization can be identified?
- Which forms lead to consensually or unanimously accepted and successfully implemented results?
- Which theoretical approaches are most appropriate to explain negotiation outcomes?

The research group assumes interdependency of original conflicts, problem setting, negotiation form, negotiation outcome and compliance; institutionalization is understood as agreement on common interpretations of negotiation issues, and on rules and norms about managing the process of problem-solving. The research group's aim is to discover economically-efficient and legally-effective forms of international negotiation that can be applied to various problems or situations.

The integration competition between Moscow and Brussels will be investigated in the framework of the all-European integration process. The enlargement of Western European institutions is limited to a few Central and Eastern European countries but will explicitly exclude others and thus form a new dividing line in Europe. In this context it will be analyzed whether Moscow is in a position to become a separate center of integration for the Eastern European states (CIS).

4 Project funding

a) External funding received

The following documents the research progress in terms of external funding received. In 2002 and 2003, a total of 15 new research projects were granted external funding. Moreover, several additional grants for ongoing projects, conferences or project development were received. External funding totalled approximately 1,0 million EUR in 2002 and 1,6 million EUR in 2003. During this period, the German Research Foundation (DFG) funded 7 new projects, followed by other national foundations (3) and funding on the EU-level (3).

According to the logic of the research programme, it is not possible to initiate the same number of new projects every year, which explains the annual fluctuations in external funding received. The total of external funding received in the eleven-year period from 1993 to 2003 was 13,0 million EUR, thus the MZES received an average of approximately 1,2 million EUR in external funding each year.

The following table provides a more detailed breakdown of the external funds received in the period 2001 to 2003. Funding for personnel costs is calculated using standard formulas (e.g. the DFG guidelines for estimating personnel costs in the current year). A project's total external funding is given under the year in which the proposal was approved (in two cases ongoing projects received further grants).
